EFNI - where ideas become policy

How can we operate effectively and ethically in a world that is changing faster than we can keep up with? Participants at the 15th anniversary edition of the European Forum for New Ideas will be seeking answers to this question. Discussions on the future will begin with a reflection on the values shaping contemporary societies. The Forum will conclude with a speech by Prime Minister Donald Tusk. The event, organised by the Lewiatan Confederation, will take place on 14-16 October 2026 in Sopot.

Today, we know enough to be able to make sense of the emerging reality. Wars, the shifting balance of power between major powers, the energy transition and the development of artificial intelligence are redefining the conditions under which businesses operate and societies function. This year's EFNI will provide a forum for discussing how to build resilience, competitiveness and long-term strategies in a world of constant change.

The event will be organised around four new thematic tracks: Our New World, Our New Europe, Our New Poland and Our New Human.

In debates on the economy, technology, security and social change, participants will not focus solely on identifying problems. The aim of this anniversary edition is, above all, to seek solutions that can translate into concrete actions by businesses, public administration and European institutions.

The starting point for this year's discussions will be a presentation of the results of the World Values Survey – regarded as one of the most important international projects examining changes in values and social attitudes. For almost five decades, this survey has made it possible to track global processes of social, cultural and civilisational change, covering most of the world's countries and around 90 per cent of its population. In the session devoted to the World Values Survey, chaired by Prof. Radosław Markowski, Prof. Christian Welzel, co-creator of the 'Inglehart-Welzel Cultural Map of the World' – widely recognised in the global social sciences – will present the global and European perspectives of the last half-century. Key findings for Poland will be discussed by Prof. Agnieszka Turska-Kawa, a member of the team analysing the WVS results.

Prof. Jerzy Hausner and Cardinal Grzegorz Ryś will then reflect on the condition of modern man, presenting the main ideas of Pope Leo XIV's encyclical Magnifica Humanitas. The opening of EFNI will culminate in a debate on 'Values and the Meaning of Life' featuring Dr Katarzyna Kasi, Prof. Karolina Wigura, Prof. Magdalena Środa, Prof. Andrzej Leder and Prof. Michał Rusinek

For 15 years, EFNI has served as a platform for dialogue between representatives of business, academia, culture and public administration. It is a place where ideas are transformed into concrete recommendations and proposals for action relating to the economy and public policy.

Our New World

A Multipolar World in Practice: Europe's Strategy Between the U.S., China, and Russia

In a world increasingly shifting toward a multipolar order, Europe faces the need to define its own strategy among the major powers that are reshaping the global framework of security, the economy, and influence. Relations with the U.S. are being tested by Washington's new approach to its global role and its partners in Europe, which, in light of recent discussions about the realignment of the alliance's strategic interests and potential tensions in the Arctic, takes on new significance for transatlantic security. At the same time, China is intensifying its economic influence, and Russia is leveraging its cooperation with Beijing and multilateral tools to challenge Western orders. Participants in the debate will consider how Europe can develop an autonomous, balanced strategy in this complex landscape: from cooperation with partners, through the management of geopolitical risks, to building economic resilience and security in the face of rivalry between Washington, Beijing, and Moscow.

The Middle East Conflict. Will This War Ever End?

The Middle East remains one of the most complex and unstable regions in the world. Successive waves of violence, shifting alliances, and the clashing interests of global and regional actors have for decades hindered the establishment of lasting peace. However, the scale of the impact of recent events—from Hamas’s attack on Israel, through Israel’s retaliation in Palestine and Lebanon, to the U.S.-Israeli strike on Iran—has turned the region’s security architecture upside down and destabilized international trade. Who stands to gain and who stands to lose from this war, and how can it be ended? What are its implications for the Gulf states, and will their development model collapse permanently? How can Europe contribute to bringing stability to the region?

Digital Extortion or Image Protection? Ethics, Algorithms, and the Battle for Business Reputation Online.

A company's reputation has become the most fragile currency in today's market. The development of generative artificial intelligence, bot farms, and the automation of online hate have made it possible to launch a massive attack on a company's reputation in a matter of minutes and at minimal cost. However, a true crisis of trust arises at the intersection of technology and the controversial business models of review aggregation platforms. Increasingly, the line between transparency and the phenomenon described by managers as "digital extortion" is blurring. Is a model in which a business owner must pay for a "premium package" or moderation services to control the damaging flood of anonymous, often AI-generated comments still freedom of speech, or has it become a modern mechanism of market pressure? During the panel discussion, business leaders, cybersecurity experts, and lawyers will attempt to define the ethical boundaries in the online platform business. We will discuss how to effectively protect companies from misinformation without silencing the authentic voices of employees and consumers, and what legal tools the market needs to curb toxic practices of monetizing fear.

Europe's Strategic Autonomy: Utopia or a Realistic Prospect?

The war in Ukraine, rising geopolitical tensions, strained relations with the U.S., and mounting challenges related to security and competitiveness have led Europe to take the concept of "strategic autonomy" seriously. However, there is no consistent definition of this concept. The prevailing view is that the European Union should "stand on its own two feet" and become independent of external suppliers, at least in strategic sectors ranging from energy to healthcare. But is this even possible in a world of such deep interdependencies? And isn't it too late for this, given the rapid development of other nations, particularly the United States and China? The panelists will attempt to explain how to understand strategic autonomy and how Europe can, in practice, strengthen its position in the world.

Nuclear Energy: between safety, sovereignty, and innovation

In the face of growing geopolitical challenges and the energy transition, nuclear energy is once again becoming a key element of strategic debates in Europe. Although in 2023 nuclear power plants in the EU generated over 619,000 GWh of electricity, accounting for approximately 22.8% of total electricity production and ranking it among the most important low-carbon energy sources, this share is declining in the long term due to the decommissioning of old reactors and a lack of major investments in new technologies. The debate on nuclear power is also a question

of energy supply security, the resilience of energy systems, sovereignty against external geopolitical influences, and the innovation of future technologies. During the panel, we will consider the opportunities and challenges for nuclear energy in Europe, how to shape investment and regulatory policy, and what impact an increased role for nuclear power in the energy mix might have on the economy and regional security.

Renewable Energy as the foundation of the energy transition: opportunities and risks for Europe and Poland

The energy transition based on renewable energy sources has become one of the most important elements of the development strategies of both the European Union and Poland.

In 2024, renewable energy accounted for an increasing share of the EU's electricity mix—solar farms generated more energy than coal-fired power plants, and the share of wind and solar in the EU's electricity reached approximately 29%. In Poland, the share of RES in electricity production rose to a record high of approximately 29% in 2024, mainly due to the expansion of wind and solar installations, although coal still dominates the energy mix. The panel will examine the social and economic dimensions of this change: the benefits of diversifying energy sources, improving air quality, creating new jobs, and reducing dependence on fossil fuels; as well as the challenges facing the system—from grid modernization and public acceptance of local investments to the need for workforce training and adaptation. The debate will demonstrate how the green transition can serve as a catalyst for sustainable development, rather than merely a cost challenge.

PPWR - a new era of packaging requirements. Will Europe be able to keep up with its own ambitions?

The PPWR sets a new course for the packaging market in the European Union. Requirements regarding the reduction of packaging, design for recycling, the use of recycled materials, and reuse systems will affect nearly every industry. The greatest challenge, however, is no longer the direction of the changes themselves, but the pace of their implementation. The Packaging Market Under the Microscope: Will Nationalization of the Sector Solve the Waste Problem?

The draft law on packaging and packaging waste is one of the most important—but also one of the most controversial—environmental reforms of recent years. Businesses do not dispute the need to implement an effective packaging return system or the “polluter pays” principle. The dispute centers on how the system should operate and its compliance with EU law. The draft bill calls for far-reaching nationalization of the system, transferring management of funds to a single public entity, and the dissolution of packaging recovery organizations. To date, no analyses have been presented confirming that such a nationalized model will be more effective than the solutions in most EU countries and will result in higher levels of separate collection and recycling. During the legislative process, concerns regarding the draft’s impact on competition were raised not only by business organizations but also by certain government ministries. Will a state monopoly actually improve the system’s efficiency, or will it instead increase costs that consumers will ultimately bear? During the debate, representatives from government, business, and experts will discuss how to create a system that complies with EU law, is environmentally effective, and at the same time supports the economy’s competitiveness.

The EU’s shrinking industrial sector under pressure from China. What can be done to maintain the competitiveness of industrial production in the EU, taking the household appliances sector as an example?

The household appliances sector is one of the largest in the EU, providing around one million jobs across more than 130 plants. The sector is particularly strong in Poland, which ranks first in the European Union and second in the world – just behind China – in terms of household appliance production. Industrial production generates real added value, drives GDP and stimulates related sectors such as transport, logistics and services. Industry is also a key driver of research, development and innovation. At the same time, we must face up to the challenges. The time to act is now! It is easier to defend existing industry than to try to rebuild it from the ruins. The key to the future lies in maintaining a modern industrial base, innovation, expertise, and research and development. It is a mistake to think that Europe will develop only services, whilst the bulk of industry relocates outside the EU. Research and development are inextricably linked to manufacturing.

The Power of Platforms: How Do Global Technology Companies Influence States, the Law and Democracy?

Global tech platforms are no longer just companies. They control communications infrastructure, access to information, citizens' data, advertising, visibility algorithms and, increasingly, the terms of public debate. Their influence extends beyond the marketplace – it reaches into governments, institutions, the legislative process, education, the media and democracy. This panel will explore how Europe can respond to the growing power of platforms: through regulation, transparency in lobbying, the protection of citizens, stronger public institutions and greater accountability on the part of tech companies.

What Poland Can Learn from Those Who Have Left the EU?

After twenty years of membership, the question of the value of Poland's continued presence in the European Union regularly resurfaces. This panel brings together three perspectives from outside Poland—from Scotland, from a Scottish institution in Brussels that closed following Brexit, and from Hungary—and complements them with an experienced Polish voice from the European Parliament. The common conclusion: the real cost of leaving the EU only becomes apparent after the exit, and by then it is too late to make corrections. What disappears overnight after leaving the European Union—in terms of institutions, market access, and regional policy? What cannot be regained after losing access to the internal market—in economic, demographic, and social terms? What does the relationship between the EU and a peripheral region (Scotland) and between the EU and a member state on the brink of conflict (Hungary) look like today from the perspective of the year 2026? What can Poland—a country still within the EU—do today to avoid the path that others have already taken?

Are Quotas Just a Women's Issue? Men on Leadership and the Responsibility to Drive Change

Poland is among the EU countries with the highest proportion of women in management positions; however, the higher up the corporate ladder, the more this representation declines, particularly on the boards of the largest publicly traded companies. On the other hand, over 44% of the population aged 25-34 in the European Union already holds a higher education degree. The debate will bring together experts, policymakers, and practitioners to reflect on key questions: how can curricula be modernized to develop the competencies of the future? How can we level the playing field in education across regions and social groups? And finally, how can we build coherent education policies that align Poland's aspirations with the ambitions of the European Education Area, focusing on innovation, resilience, and inclusivity?

The Aspirations of the Younger Generation. How Do We Plan Our Future?

Generation Z is entering adulthood amid profound social, economic, and technological changes. Health in Motion: How does physical activity strengthen society and the healthcare system?

Physical activity is one of the most effective tools for preventive healthcare—it reduces the risk of chronic diseases, improves mental well-being, and tangibly reduces the workload on healthcare systems. Poland is also making efforts to increase physical activity—from mass sports to
